

Sept 7, 2021

Mayor Brad Crain called the meeting to order at 7:00 p.m.
Minutes from the August 16, 2021 meeting were approved.

Mayor Crain presented 2022 Budget for hearing, he asked if anyone present to remonstrate.
No one was present.

LeAnn Zoerb was present to ask permission to close off block of 7th St from Jefferson to Washington Street to have a block party from 5:00 to 11:00 p.m. They have asked the neighbors and got permission with them also. Council agreed to let them have it. October 9, 2021.

Samantha Walls was present to ask permission to have car show at the City Park to raise money for a friends family that passed from Covid to help raise money for the family. They would like to have it Oct. 3, 2021. They would like to have the big pavilion to have a band and pop up vendors, Chris will check and see if the big pavilion is available. Council agreed to allow it.

Jack Keller was present to ask about the road situation on Liberty Street at 211 Water Street. He said the road is in bad shape. Mayor Crain asked Rick Smith to get some patch and look into it to fix it.

Julie Root was present to ask permission to put a large coffee cup made by Brian Abernathy in memory of Marissa Goley and advertise for the coffee shop. Mayor Crain suggested we remove the sod in front of Douglas and Nelson and we will put it there. Council agreed to allow it.

Mayor Crain brought up the situation of people putting out furniture, mattresses, TV'S along the streets and in their yards, the suggestion is that we put a large fine in our ordinance and start enforcing it.

Mayor Crain will get ahold of Attorney Powell and have a fee put of the ordinance and it will be advertised.

Superintendent Myers said the pool is drained, and he still waiting on Pittsburg to finish up at the tower.

Brian Falletti was present to voice a concern over an incident by Police officers that he had reported to Chief Sowers. Mayor Crain told him this wasn't a council issue and he would grant him permission to speak with Chief Sowers , Mayor Crain, and Board of Works and listen to his issue.

Chief Sowers said the 21 Explorer is almost ready to start driving, they are just waiting on some caging to be delivered and installed. He also asked permission to do some work at the dog pound, he will have Allen Strawser give a quote.

Superintendent Karushis Thanked the Council for approving the purchase of his new truck.

Councilmember Hegg asked about UTV having to require helmets for all under 18, it is a law through the state. This does not include a Golf cart.

Councilmember Sare asked about the pole to install at park Councilmember Salts said he found an 85 foot cedar pole but we would have to pay freight. Councilmember Salts will continue to look into it, he says he feels he will be able to find one that we might not have to pay the freight on.

He suggested we get the sand blasting started on the pool, and all upgrades in the bath house

Councilmember Smith asked about the roof replacement on the big pavilion, said it will be included in the grant we have applied for.

Councilmember Tanner asked putting in the large meters in the schools, Mayor Crain will get AJ Lewis to look into it and getting them replaced. He also brought up about the parking situation at the Park near the Disk Golf holes.

Police Officer Alexander asked about getting parking moved 30 feet from Stop Sign and painted yellow on 3rd Street by the new McDonalds.
