



A discussion was held by the Council and they will consider it at a future meeting.

Mayor Crain and Clerk-Treasurer Knecht met with RT Insurance today and they quoted our health insurance as the Cities health Insurance through Anthem expires January 1, 2026. They quoted cheaper than Anthem with a \$500.00 deductible. Clerk-Treasurer Knecht will check with insurance company to get a list of all coverages and more information for the Council on the December 1st Council meeting.






